**CREST CLEAN OBRA®** is a concentrated acid cleaner, designed to remove cement inlays and grout remains on ceramic, as well as mineral deposits and efflorescence. Additionally, it is effective in removing tartar, lime and soap residues. **CREST Clean Obra®** should not be applied to acid sensitive coatings such as marble, calcareous stone, mud, etc. Do not leave exposed for longer than indicated in the instructions.

## Benefits

- Acid action detergent.
- Removes incrustations or deposits derived from construction.
- Eliminates salts and efflorescence.

## Suitable Tile Types

- Cement-sand base grouts.
- High, medium, low and no absorption of moisture tiles

## Limitations

You should not apply **CREST Clean Obra®** on acid sensitive tiles such as marble, calcareous stone, mud, etc.

## Mixing Procedures

Prepare the mix or dilution of **CREST Clean OBRA**, depending on the difficulty to remove scale or nozzle residue. Start with the most dilute solution (1-5); if scale persists, try a concentration of 1-4 and so on until complete cleanliness is achieved.

## Product Application

USE CHEMICAL-RESISTANT GLOVES, such as nitrile, when handling products

1) Test in a small, inconspicuous area to see effectiveness and results, as well as verify that the floor is not adversely affected.

2) Spray the area to be cleaned until it is generously covered with the **CREST Clean OBRA** solution.

3) Wait about 1 minute for it to work.

4) Scrub the surface with a nylon brush to remove stains.

5) Rinse the surface with plenty of clean water to ensure that the cleaner is completely removed.

## Recommendations

It is recommended to use **CREST Clean Obra** for cleaning before installing a coating over an existing one. Rinse with plenty of water.

## Protection

May be harmful or fatal if swallowed. May irritate eyes and skin. This product is combustible and contains petroleum distillates. Use in ventilated areas. Use vapor mask, gloves, goggles and appropriate clothing. Avoid exposure to high concentrations of vapors.
